March is Women's History Month. According to google, Women's History Month celebrates the often-overlooked contributions of women in history, society, and culture. It has been annually observed in the United States and other countries, including the United Kingdom and Australia, every March since 1987.

March 8th, International Women's Day (IWD) celebrates the achievements of women. The day also marks a call to action for accelerating women's equality. IWD has occurred for well over a century, with the first IWD gathering in 1911 supported by over a million people. International Women's Day has been sponsored by the United Nations since 1975. IWD grew out of efforts in the early 20th century to promote women's rights, especially suffrage. In its campaign for female enfranchisement, the Socialist Party of America in 1909 held the first National Woman's Day. Mass meetings were held across the United States. In some countries International Women's Day is a holiday.

Zonta International celebrates Rose Day on International Women's Day on March 8th and asks each club and each member to recognize women who make a contribution to society. When we donate flowers to the women who are residing in Heartly House, we recognize their courage; their courage to change their lives, to keep their children safe, and to survive.

Zonta International stands with our members in Ukraine

We have been in communication with our Zonta members in Ukraine and are inspired by their strength and resilience as evident in the excerpt of their message below.

“We are calm and resolute; we keep in touch with family and friends. The main thing is that we maintain our strength of spirit -- then we will not be defeated. Today, Ukraine needs us, and we are called on to give a part of ourselves if we are to live in a democratic country governed by the rule of law.”

As a global organization dedicated to working for the advancement of understanding, goodwill and peace through a world fellowship of members and promoting justice and universal respect for human rights and fundamental freedoms, we strongly condemn foreign aggression and acts of war, as are being witnessed in Ukraine.

We know that in times of conflict and war, women and girls, especially those who are

displaced from their homes, are at increased risk of sexual and gender-based violence. Women also bear the primary burden of keeping their families together, ensuring the safety and wellbeing of their children and addressing the long-term emotional and physical damage inflicted by war.

As women and children move from Ukraine into neighboring countries, we encourage our global membership to use their voices to advocate to ensure that the safety and wellbeing of women and girls are at the forefront of the humanitarian response. We also know that our members are generous and want to directly support Ukrainians and their immediate needs. While Zonta International is not positioned to respond to emergencies, we encourage our members to direct their support to relief organizations like our long-time partners at UNFPA and UNICEF that are already working on the ground in Ukraine and in nearby countries that are accepting refugees. We also acknowledge that Zonta District 27, of which Ukraine is a part, is also working with local Zontians to assess and respond to local needs.

As I said in my earlier statement, Zonta International will continue to build and support a global community of individuals who share a common commitment to equality and peace for all.
